

PROFESSOR R. MICHAEL BAGBY

In this academic year Professor Bagby welcomed into his lab Dr. Tochukukwu "Charles" Ojiakor as a post-doctoral fellow. Dr. Ojiakor received his Ph.D. from the University of Nigeria, Nsukka and is received a two-year post-doctoral fellowship from the University of Toronto Scarborough to work with Professor Bagby in exploring the effects of Black racialization in North America on the measurement of personality psychopathology.

PROFESSOR MICHAEL BEST

Professor Best is currently leading a clinical trial examining the efficacy of combined cognitive remediation and cognitive behavioural therapy for schizophrenia, which represents one of the largest psychological intervention trials to ever be conducted for schizophrenia. Professor Best has trained over 60 clinicians in CBTp and CR across Ontario in the past year as part of this study. Professor Best was also awarded a SSHRC Insight Development Grant to examine reasons why individuals with schizophrenia face social exclusion and how this impedes recovery.

PROFESSOR JESSICA DERE

Professor Dere co-presented a talk at the annual convention of the Canadian Psychological Association that took place in June, titled Recommendations and guidelines for establishing and maintaining co-supervision arrangements in graduate level psychology training. This talk was part of a symposium organized by the CCPPP Working Group Against Racism and Discrimination in Canadian Psychology Training and Practice, of which Dr. Dere has been a member since 2020.

PROFESSOR VINA GOGHARI

Professor Goghari is a recipient of the University of Minnesota, College of Liberal Arts (CLA), Alumni of Notable Achievement Award, which celebrates and honors the significant achievements and contributions of alumni. She also became a Fellow of the Association for Psychological Science, which is awarded for sustained outstanding contributions to the science of psychology in the areas of research, teaching, service, and/or application.

PROFESSOR ANTHONY C. RUOCCO

Professor Ruocco's research on magnetic seizure therapy was recently published in the inaugural issue of Nature Mental Health and featured in <u>an article</u> <u>published by the Brain & Behavior</u> <u>Research Foundation</u> and in <u>a news article</u> <u>from the University of Toronto</u>. He was also awarded a new research grant from the University of Toronto's Inlight Student Mental Health Research Initiative.

PROFESSOR ZINDEL SEGAL

Professor Segal led a 5 day Mindfulness Based Cognitive Therapy training workshop in French at Crêt-Berard – Christian Retreat Centre in Puidoux, Switzerland. Days started at 7am and ended at 8pm, with periods of meditation, silence, clinical training and supervision. He also published a paper showing that the mediators of change in online Mindfulness Based Cognitive Therapy are similar to those when the intervention is delivered in person – decentering, mindfulness and rumination. PROFESSOR ANDREW COOPER

Professor Cooper was a 2023 nominee for the tricampus Early Career Teaching Award, and began his sabbatical in July 2023.

PROFESSOR AMANDA ULIASZEK

Professor Uliaszek continues her work as an advocate and researcher for postsecondary student mental health. She received a \$30,000 Inlight grant to explore the intersectionality in students with disabilities. In addition, she was the faculty lead for the International Student Mental Health Summer Research Institute, which brought together students and faculty from Canada, Taiwan, Australia, and the UK to drive innovative research solutions to the worldwide student mental health crisis. This Institute was funded by a Connaught Global Challenge Research Program and **Connaught Global Research Impact** Program.

PROFESSOR KONSTANTINE ZAKZANIS

In 2023, Professor Zakzanis was awarded a 5year \$90,000 MITACS research award as the sole principal investigator to examine the relationship between Diversity and the Validity of Test Findings in Neuropsychological Practice. Professor Zakzanis also remains as the standing President for the Canadian Society for Medical Evaluators, a non-profit organization and is the first Psychologist (non-physician) to hold this title where he continues to actively direct multiple certification programs for clinicians.





Dr. Amanda Ferguson Class of 2022

Dr. Amanda Ferguson was offered a Junior Research Fellowship at Darwin College, University of Cambridge. This prestigious position is awarded to select early-stage academics who are conducting excellent research and will allow Dr. Ferguson to join the college as a member of the Governing Body. In this role, Dr. Ferguson will be using basic and applied methods to investigate how technology amplifies mental health risk and resilience across development. Despite the pervasive influence of technology in everyday life and growing concern that this is negatively impacting young people, research has failed to produce robust and actionable findings for the public. Dr. Ferguson's program of research takes a novel mechanistic approach to investigate phenomenological and cognitive mechanisms underlying the impact of digital technology on mental health.



Dr. Achala Rodrigo Class of 2022

Dr. Achala Rodrigo joined York University as an Assistant Professor in the Department of Psychology, in the area of Clinical Neuroscience and Neuropsychology. Using a multi-method approach that combines traditional neuropsychological assessment and novel neuroimaging techniques, his program of research examines the complex relationship between higher-order aspects of cognition and clinically relevant behavioural outcomes. His research also aims to elucidate mechanisms through which psychological distress may negatively impact cognitive function, and in turn lead to maladaptive behaviour.

After graduating from UTSC's Clinical Psychology program, Dr. Katherine Gardhouse and Dr. Tara Gralnick founded a mental health centre called eFIT Institute. The centre incorporates psychological, physical, and social aspects of health, and is the first in Canada to subscribe to a membershipbased model of mental health care.

Members enrolled in the centre participate in an individually tailored, systematic, and evidence-based group psychotherapy program. Members are first enrolled in a group where they learn to deeply understand their case conceptualizations and to apply this understanding in their every day lives. The group is not psychoeducational, but is process-oriented and experiential in nature, primarily following an Emotion Focused Therapy paradigm. Members graduate from this group when they have deeply integrated their case conceptualizations into their understanding of their experiences, and

regularly identify: (1) their secondary emotions (and automatic thoughts connected to them); (2) their underlying primary emotions (and core beliefs connected to them); and (3) the traumatic experiences in their life histories leading to their primary emotions at the core of

their case conceptualizations. Members then enter a trauma and emotion-focused processing group, where time is spent helping them emotionally process the painful experiences they endured lying at the root of their ongoing difficulties.

Given that trauma and emotional pain often manifest physically in the body, members are also offered daily in-person classes to help them develop a sense of awareness of their bodily stress, and recalibrate their autonomic nervous systems to reduce dysregulation and increase parasympathetic tone. Members also work with our psychologists and dietitians to develop a customized nutrition plan. It is of note that eFIT Institute will be accepting practicum students, who will have an opportunity to conduct individual therapy (using an integrative therapeutic approach, drawing from Emotion Focused Therapy, Cognitive-Behavioural Therapy, and Dialectical Behaviour

Therapy) and to co-facilitate aforementioned groups (which draw primarily from Emotion Focused Therapy). Practicum students will

have an opportunity to work with clients experiencing complex presentations, struggling with a broad range of difficulties. Feel free to contact Drs. Katherine Gardhouse (<u>katherinegardhouse@efit.institute</u>) and Tara Gralnick (<u>taragralnick@efit.institute</u>) if you're interested!

Dr. Nadia Al-Dajani Class of 2020

Dr. Al-Dajani recently accepted a position as Assistant Professor in the Department of Psychological and Brain Sciences at the University of Louisville. There, she will continue to focus on examining shortterm risk and protective factors of suicidal thoughts in youth and young adults. She will extend her work by focusing on unique stressors faced by minoritized populations which could explain the unprecedented rise in suicide deaths in these youth. She hopes her research will inform future prevention and intervention efforts, particularly those focused on momentary suicide risk. Dr. Al-Dajani

was also recently awarded a young investigator award from the American Foundation for Suicide Prevention. This project seeks to improve prediction of momentary suicidal ideation by using multiple

daily surveys to capture risk and protective factors that precede suicidal thoughts. Young adults between 18–25 years old who recently visited the emergency department due to suicide risk will be recruited for this study. Nonlinear dynamic statistical modeling using the cusp catastrophe model will be used to identify the compounding effect of

multiple factors measured over time to improve suicide risk prediction. This project is carried out in collaboration with University of Cincinnati Health and under the mentorship of Dr. Cheryl King, University of Michigan.
