Living Away from Parental Home: If you normally live at home but will need to move away for either the work term or the study abroad term, you may need to adjust the living costs on your OSAP application. You must submit a <u>Request for Review</u>: <u>Adjust Living Allowance form</u> to be considered for additional funding.

OSAP Obligations: As an OSAP recipient you are required to report any changes to: personal information, study period and program information, as well as study period income and financial resources. You must ensure <u>all</u> the information on your application is accurate and up-to-date.

I understand that income information for me and my parent(s) (or spouse) will be verified with the Canada Revenue Agency (CRA). Failure to verify the income on my application will result in grant funding being converted to a loan. Some Things to Consider

Before applying for funding during a co-op work term, here are some things to consider:

- You must include your co-op earnings on your application as study period income
- You may incur more debt
- Your study and work terms are considered separate study periods and the appropriate reinstatement/extension forms must be submitted through the academic year by the required deadlines for each individual study period
- You will use up more terms of your **student grant lifetime limit**. The Ontario Student Grant is limited to a lifetime maximum of eight (8) terms of funding.
- You will use up more weeks of your OSAP lifetime limit. The lifetime limit of student loan funding is:
 - 340 weeks of funding
 - 400 weeks of funding for doctoral studies
 - 520 weeks of funding for students with permanent, persistent or prolonged disabilities
