- In order to be eligible for Part-time OSAP you must be a part-time student. To be considered part-time you must be registered in a course load of 20% (1 half credit) or 40% (2 half credits) in <u>each</u> semester.
- Study periods cannot overlap with a study period that is funded through Full-time OSAP, Part-time OSAP or through another application or Institution-Funded Special Bursary.
- To maintain eligibility for Part-time OSAP, you must successfully complete <u>all courses</u> for which funding
 was issued. Not meeting this requirement may result in being placed on PT OSAP restriction. This change
 may result in a loan and/or grant overpayment. To regain PT OSAP eligibility, you will be required to
 successfully complete one semester through self-funding. Doing so will make you eligible for funding in
 a subsequent part-time study period.
- Students registered in a Co-op program are **NOT** eligible for Part-time OSAP funding during a co-op work term.
