4. Enhancement Fund Subcommittee

a. Sub-Committee Motions

Ms Arnason reviewed the funding requests that were granted funding for the third round of the CSS Enhancement fund. The highlights were that CSS continued to fund projects from students that enhance the quality of the student experience at UTSC. The total funds requested in Round 3 were \$17, 968.00 and the total funds allocated were \$16, 270.00

The Enhancement Fund Sub-Committee put forth the following motions:

- BIRT CSS approve up to \$1200.00 for SCHPA's "UTSC Extramural Hockey Tournament"
- BIRT CSS approve up to \$700.00 for Association of Philosophy Student's "Undergrad Philosophy Conference"
- BIRT CSS approve up to \$7000.00 for UTSC SAA's "2010 SAA Culture Show"
- BIRT CSS approve up to \$825.00 for Alpha at UTSC's "Alpha at UTSC"
- BIRT CSS approve up to \$500.00 for UTFCD's "University of Toronto China Conference"
- BIRT CSS approve up to \$3000.00 for uSCIENTIA's "uSCIENTIA Journal"

Ms. Arnason said that a lot of clubs don't claim the money that they've been approved. Mr. Cole asked about the committee's previous concern about not enough people applying for the enhancement fund. Ms. Arnason said that they are attempting to streamline the process in the future so groups can apply once online for each fund. Mr. Aruldason There were no further questions.
