Services
Motions 1998-99**

1. SPACE AGREEMENT - Motion Carried

Be it resolved that CSS mandates the Associate Vice-Principal to negotiate a letter of agreement between the University and the CSS, which shall guarantee student space or its equivalent n.a.s.m. based on the current inventory of student space.

2. STUDENT CENTRE - Motion Carried

Be it resolved that CSS recommends to the Principal and Dean, Professor Paul Thompson, that a University Users Committee be established to study the feasibility, costs, financing and programmatic issues related to the building of a student centre on the University of Toronto at Scarborough campus and that such a committee be proposed to the Office of the University Provost no later than April 1, 1999.

3. PHYSICAL ENVIRONMENT/SCHOOL DÉCOR

(a) Aesthetic Improvements Notice of Motion - Motion Carried

CSS recommends to the Site Planning Committee that student artwork be utilized throughout the campus buildings to enhance the aesthetic environment, to showcase student talent and to bolster school pride and that a plan be so implemented before October 1, 1999.

(b) Washroom Cleanliness - Motion Tabled

CSS recommends to the manager of Physical Plant Services Building Division, Mr. Brian Smith, that a systematic review of the washrooms be conducted for the purpose of identifying any facilities which may require special and on-going attention with a view to improving their cleanliness and that such a review be concluded before the end of the Winter '99 academic session.

(c) Flags, Main Campus Entrance and Illuminated Signage - Motion Carried

CSS recommends to the Site Planning Committee that three flags are erected at the main public entrance off Military Trail, specifically those of Canada, Ontario and the University of Toronto. Also, a concrete or stone monument sign be erected in a prominent and public location engraved the University of Toronto Coat of Arms, with the words "UNIVERSITY OF TORONTO AT SCARBOROUGH" and that this monument be illuminated at night. Lastly, a firm is engaged to design and propose the construction of architectural features to distinguish the main entrance to the University campus.

4. NAMING AND IMAGE ISSUES - Motion Carried

Whereas the students wish to deepen their appreciation of the history of the Scarborough campus, enhance their school pride and improve its image and identity, CSS recommends to the

Site Planning Committee that the H, S and R Wings be re-named in a manner which reflects history and tells the Scarborough story and that plaques be erected in recognition of that story. It is further recommended that this project be completed no later than January 15, 2000.

5. CLUBS ROOM - Motion Carried

Be it resolved that CSS allocate \$4,750 to Club Centre renovations.

Be it further resolved that CSS allocate \$3,500 to Club Centre resources.

Be it further resolved that CSS allocate \$1,750 to furnishing the Clubs Centre.

6. WOMEN'S CENTRE RENOVATIONS - Motion Carried

Be it resolved that CSS approve \$6,000 for R-3018 renovations.

7. STUDENT LEADERSHIP AWARDS - Motion Carried

Be it resolved that CSS approve the \$800 proposal.

8. MULTI FAITH PRAYERS SPACE - Motion Carried

Be it resolved that CSS approve the \$8,700 project.

9. STUDENT SUCCESS FACILITATOR'S OFFICE - Motion Carried

Be it resolved that CSS approve the \$8,700 project.

10. STUDENT LEADERSHIP PLANNING & PRIORITIES RETREAT - Motion Carried

Be it resolved that CSS approve the \$5,000 retreat.

11. STUDENT MEMBERSHIP (SCARBOROUGH DEVELOPMENT DIRECTORATE) - Motion Carried

Be it resolved that CSS request the Chair of SDD to include a student as a voting member of SDD.
