## **1. STUDENT ENHANCEMENT FUND PROPOSALS – Motion Tabled**

- Hindu Students' Council - \$300

## **2. AMENDING PROCESS FOR APPROVAL OF STUDENT ENHANCEMENT FUND – Motion Carried**

Be it resolved that student groups requesting funding from the Student Enhancement Fund be invited to make a presentation to the Council in general session.

## **3. ENHANCEMENT FUNDING FOR STUDENT GROUP EVENTS IN THE ATTIC – Motion Carried**

Be it resolved that a minimum of \$5,000 be set aside from the Student Enhancement Fund for 2001-2002 in order to help defray the cost of using the Attic by recognized student groups during the evening hours.

Be it further resolved that the Attic Funding Guidelines be revised to reflect an increase in funding up to \$900 per club for an annual total of \$5,000.
