Motions 2003-04

1. AD HOC BOOKSTORE ADVISORY COMMITTEE – Motion Carried

Be it resolved that CSS strongly recommends to Jack Martin that an Ad Hoc Advisory Committee be organized to deal with bookstore needs as soon as possible.

Be it further resolved that the composition of this committee include a substantial number of members from CSS.

2. COSS REPRESENTATIVE – Motion Carried

Be it resolved that Preet Viridi be the CSS representative on COSS.

3. BOOKSTORE WORKING GROUP – Motion Carried

Be it resolved that CSS strike a UTSC Bookstore working group as described by Jack Martin, and that the member on the working group be member of the SCSU as well as a member of CSS.

4. COMMITTEE TO REVIEW THE CSS CONSTITUTION – Motion Carried

Be it resolved that the CSS Constitutional working group be comprised of the following individuals: Tom Nowers, Ryan De Mello, Paul Hunter and Curtis Cole.

5. COMMITTEE TO REVIEW THE ENHANCEMENT FUND PROPOSALS – Motion Carried

Be it resolved that an Ad Hoc Committee of CSS, composed of 3 students, a service provider and chaired by a member of Student Affairs, be established to review Student Enhancement Fund proposals and forward their recommendations to CSS for approval.

6. ALCOHOL POLICY – Motion Carried

Be it resolved that CSS recommend to the executive committee the proposed amendment which is to provide all UTSC students, regardless of age, an equal opportunity to participate in the full range of social activities.

Be it further resolved that events on campus while at the same time ensuring minimal risk of the Liquor License Act with respect to underage possession and consumption of alcohol, underage access to licensed events and facilities will be limited to University of Toronto students.

Be it further resolved that this amendment be accompanied by a demonstrative increase in the educational efforts to raise awareness of the risks associated with underage drinking. There was a friendly amendment put forth that this policy should apply to all University of Toronto students, not just UTSC students.

7. STUDENT HOUSING REPRESENTATIVE – Motion Carried

Be it resolved that in the absence of a Director of Student Housing and Residence Life, Celine Ariaratnam sit on CSS to represent the department until the search for a new director is complete.
